

TRANSITION INSTRUCTIONS: COMMERCIAL WINERY – NEW REMITTANCE MODEL

Current Model – Reporting and Remittance Instructions

Please complete the following steps in order to report your final direct sales batch(es) under the current model, in readiness for your transition to the new remittance model.

- 1. **MARCH 3** this is the last **batch date** for transactions under the current model. The March 3 dated batch should include transactions prior to, and including, March 1.
- 2. MARCH 5 this is the last submission date for batches under the current model.
- 3. **MARCH 5** this is the last **date to deposit** sales proceeds from the current model into your LDB Bank Account. Please ensure that all outstanding balances are brought up-to-date.

Future Model – Reporting and Remittance Instructions

Please complete the following steps in order to commence reporting direct sales and remitting under the new remittance model.

- 1. **FEBRUARY 21** return the completed and signed PAD agreement (and supporting documentation) to LDB by this date.
- 2. MARCH 4-6 Black-out period for batch submissions. Please do not report any batches in DSWR during these days. You can continue creating transactions (individual orders) in DSWR during this period but do not submit any batches dated MARCH 4 and onwards during this period. Batches submitted over these days will be rejected. The LDB needs this time to change its systems to transition to the new remittance model.
- 3. MARCH 7 You can submit batches in DSWR from this day onward. This is the earliest batch date (and submission date) for batches to be reported under the new model. Please note: transactions from March 3 onward will be reported in this first batch under the new model.

Mar-05 Last submission date for batches (dated March 3).
